## GENERAL RULES

1. Junior exhibitors will be limited to youth in good standing with their 4-H Clubs or FFA Chapters. Reports will be turned in to show management along with grades, if requested. The exhibitor must be attending regular classes in elementary, intermediate, or high school throughout the feeding period and must be passing at the last grading period prior to the show. Exhibitors must be in good standing with their school and eligible to participate in all aspects of the show on the first day of the show and remain eligible for the duration (February 14th – March 3rd) as deemed by their respective school administrator. Exhibitors transferring from one school to another (public, private or home school) within four weeks of the Victoria Livestock Show will be eligible or ineligible under the originally attended school. An exhibitor must be at least 8 years of age and in the 3rd grade or 9 years of age by August 31, 2024 and have not reached their 19th birthday on or before August 31, 2024.
2. **All entries for the Victoria Livestock Show must be made online at [www.victorialivestockshow.com](http://www.victorialivestockshow.com). The website will be available October 1, 2024 thru December 1, 2024. ENTRIES MADE ONLINE AFTER DECEMBER 1 WILL BE CHARGED A \$50 LATE FEE. NO LATE ENTRIES WILL BE ACCEPTED AFTER DECEMBER 31<sup>ST</sup>. Please bring two copies of your receipt with you to tag in.**
3. The junior show will be open to Victoria County 4-H and FFA members if they (1) reside in Victoria County throughout the total feeding period, and (2) attend regular school as defined in rule 1 above. Goliad FFA, Industrial FFA and Cuero FFA members may also participate if they (1) reside in Victoria County throughout the total feeding period, (2) attend regular schools as defined in rule 1 above, and (3) if they have both market and breeding animals, both must be entered and shown in the Victoria Show to be eligible to

enter. No others will be allowed to exhibit in the Junior Market Show unless special permission is obtained annually from the Victoria Fair Association Board of Directors before October 1st prior to the show year.

4. Any junior exhibitor will be limited in their eligibility to sell a Grand or Reserve Grand Champion in the Market or Carcass divisions based on a point system. Two (2) points will be tallied for Grand and one (1) point will be tallied for Reserve Grand. Over the exhibitor's show career, he/she will no longer be able to show in the division in which he/she reaches a total of seven (7) points. This rule will be retro-active to the 2013 Victoria Livestock Show.
5. Each entry must be the bona fide property of the exhibitor. In the junior classes, the animal must have been owned and fed by the exhibitor. Exhibitors must own their market and carcass sheep, goats and hogs by their tagging date. Steers can be purchased anytime and left on its dam or nurse cow but must be weaned and in possession of the exhibitor by the steer tagging date, prior to the show. All projects will be fed and cared for by the exhibitor during that feeding period. No animal owned by a Club or Chapter will be eligible to be shown or sold.
6. Animals in all classes will be under the supervision of the exhibitor. In no case will the Victoria Fair Association, its management or any Victoria Livestock Show official be responsible for any loss, damage or injury to any person, exhibitor or animal. No claim for injury to person or property shall be assessed nor suit instituted.
7. Each exhibitor is expected to keep his/her stalls, pens and exhibits clean, neat and with fresh bedding daily until the animal is removed from the barn or is sold at the auction. Be mindful of Camp Sizes in Show Box / Stall areas. Keep walkways / aisles clear and open ingress / egress. For those who refuse to comply, it will be up to the discretion of the show management to ban the exhibitor from the Victoria Livestock show for at least one (1) year.



8. Each entry in the Junior Division must be shown and sold by its owner unless another 4-H or FFA member is authorized by the show officials.
9. Competent judges will be provided by the show management for all classes of livestock. The judge's decision on all placing will be final.
10. Weighing Market Classes
  - a. All entries in the Market Classes (except Broilers) will be weighed on the grounds by a committee appointed by the show management. This will be the official weight for all purposes.
  - b. Any re-weigh for animals not meeting minimum weight or those exceeding maximum weight must be called for immediately and must be done before the next animal is weighed. The animal will be held at the scale area until the scales have been cleaned and balanced and the animal's weight re-checked. If on the second weighing the animal does not reach the minimum weight or exceeds the maximum weight, the animal will be disqualified.
11. An exhibitor can raise any number of steers, hogs, lambs, rabbits, goats, or broilers or any combination of these in both market and carcass divisions. Rabbits, goats, and boilers are not eligible for the carcass division. Exhibitors can raise only 50 broilers. Any number of heifers and gilts may be raised for the breeding divisions. The exhibitor can only show one market and one carcass entry, and they may be of separate species. If an exhibitor is ineligible to show, no one else can show the animal for him/her. If an animal is sifted it is considered shown and no other species may be entered at that point. An online entry and a fee must be submitted for each Market Division entered. Junior exhibitors may sell only one entry in the Auction

Sale. Junior exhibitors may show any number of entries in the breeding show but are limited to two in the Junior Breeding Beef Heifer Show. All live animals placing high enough to make the sale will sell. An exhibitor who makes the sale with both live and carcass animals must sell their live animal. Exceptions being: Grand and Reserve Grand carcass champions will be sold instead of live animals. If an exhibitor exhibits a Grand and/or Reserve Grand champion in both live and carcass divisions that exhibitor will be given a choice of which animals will be sold. The decision must be made prior to the live animal leaving the show ring. All placing will remain the same regardless of any champion not selling. All Grand and Reserve Grand champion animals will remain in the show barn or in the cooler throughout the show.

12. Show management will furnish initial bedding in the Junior Division. Exhibitors **must** furnish additional bedding for all animals except for broilers.
13. No awards from other shows will be exhibited on pens and stalls.
14. No advertising or promotional materials other than school, 4H or FFA materials will be permitted in pen or stalling areas.
15. Health Regulations:  
All animals must meet the Texas Animal Health Commission requirements for "Admission of Livestock to Shows, Fairs and Exhibits". Veterinarians will be at the show to check animals. Any animal requiring blood tests must have such tests within the prescribed time of the show. Steers, hogs, lambs and goats will be inspected upon entry to the show grounds by an approved veterinarian. All sexually intact female lambs and goats

must have an official USDA Scrapie Eradication Program identification ear tag. All breeding animals must meet state requirements regarding freedom from tuberculosis and brucellosis. (See your veterinarian for details on breeding animals.) When required by the Texas Animal Health Commission, health papers are required at check-in.

16. No pumping, filling (of the animal) or tampering to change the natural conformation or appearance of market animals before or during the show will be permitted. This rule will be strictly enforced by the Victoria Livestock Show officials.
17. It is expected that all exhibitors are of the highest moral character and integrity and any violation of good order will subject the offender to such action as the show management deems advisable.
18. Closing time – Wednesday – Saturday 11PM till 5AM, Sunday 9PM – 5AM. No exhibitor, parent, or unauthorized person may remain in barn.
19. Show management reserves the right to interpret these rules and regulations and settle and determine all matters regarding the show. They shall also have the right to amend or add to these rules as its judgment may determine. An exhibitor who violates any of the rules of the show can be ejected from the show along with his or her animal and be refused to exhibit at all future shows as well.
20. No animal may be removed from the grounds without a special release signed by the Chairman of that division.
21. Exhibitors are responsible for feeding and watering animals until removed by VLS division committee

members. Failure to do so will result in forfeiture of animal to VLS and/or any resale value from the show.

## **22. DISPOSITION**

Market animal exhibitors will have an option which will dictate how the animal is handled through the show. The exhibitor can choose to enter the animal as either (A) TERMINAL ANIMAL or a (B) PREMIUM ANIMAL.

### **(A) TERMINAL – ANIMAL IS SLAUGHTERED**

As in previous year's shows, regardless if the animal is sifted or makes sale, the animal will be slaughtered. The exhibitor needs to choose a processor when registering to decide a slaughter house or VLS. If an animal does not make the sale, the market animal will be hauled to a slaughter house chosen by the exhibitor at time of registration, and the exhibitor is to contact the slaughter house for instructions for slaughter and payment fees. If VLS is chosen, the exhibitor will receive a check from the Victoria Livestock show for the market value of the animal and no meat will be available to the exhibitor.

### **(B) PREMIUM – ANIMAL IS TAKEN HOME BY EXHIBITOR**

The exhibitor will be given a sale lot and the monies received will be for a premium only and the exhibitor retains ownership of the animal. Premium animals will be taken home by the exhibitor regardless if the market animal makes the sale or does not make the sale.

Market animals that make the sale: There will be no meat available for the buyer on auction night and will be identified on the sale sheet as a premium animal.

If the animal makes sale or does not, all exhibitors are responsible for their animal until the time and date of release for their breed and division. All exhibitors will be responsible for hauling their own animal. Market animals making the sale will all haul-out the same day as the non-sale animals.

Premium market animals – a release schedule will be provided at the Victoria Livestock Show with date, time and instructions for haul-out by the disposition chairman.

Disposition choice as described above for all market animals (market hogs, lambs, goats, steers, rabbits, and broilers) is to be determined by the exhibitor at the time of registration through ShoWorks regardless of the market animal not making required weight, or making/not making the sale. The deadline for disposition changes is January 31, 2023 and any changes will need to be emailed to the disposition chairman.

23. The exhibitor will assume responsibility for dispositions of their steer, hog, or lamb carcass if they do not make the sale and all carcasses are not purchased by the processor. If all carcasses are not purchased, exhibitors must make arrangements with the processor no later than four (4) days following the auction. The Saturday after the sale, the meat processor may begin processing any carcass that the instructions have not been given on. **The owner will be responsible for all costs.** Any carcasses left after 30 days will be donated to local charities.
24. No scales other than the official ones are allowed in the barn. Scales in the barn are for official use only.
25. The Victoria Livestock Show reserves the right to use any animal in the Victoria Livestock Show Judging Contest.
26. Illegal Use of Drugs in Animals  
Exhibitors must ensure that his/her animal:
  - a. has not received any substance not approved by the Food and Drug Administration (FDA) and/or the U.S. Department of Agriculture (USDA) and
  - b. is not within any withdrawal time relative to the administration of any drug, chemical or feed additive

approved by the FDA and/or USDA when the animal is weighed in for the Livestock Show. If FDA/USDA conducts unannounced inspections and testing, any animals testing positive will be disqualified and the ranking of all other animals will remain unchanged. If any animal is condemned for any drug related reason by a packer, the exhibitor will be responsible for any loss incurred by the packer and/or the buyer.

27. Any unruly animals may be sifted at the discretion of the officials at any time during the show.
28. No cell phones will be allowed in the show ring.
29. Quality Counts verification will be required for all youth exhibiting livestock (market and/or breeding). The verification process will require junior exhibitors to pass an online test that measures their knowledge on quality assurance and character education content items. Exhibitors can go online to take the test and become verified. A verification number will need to be provided at the time of making an official entry into a VLS show. Thus, youth will need to have completed and passed the test before the VLS entry deadline. A passing score has been determined to be 80%. Website: <http://agrilife.org/qualitycounts/verification/>

31. NO unloading in Pole Barn on Wednesday from 3PM – 5PM (while hogs are unloading).
32. NO GLASS BOTTLES OR CONTAINERS ARE ALLOWED IN SHOW BARNES.
33. Only Service Animals are allowed on show grounds. NO PETS.
34. Zero Tolerance for disrespectful behavior, swearing at show officials & security team. Any Exhibitor, Parent or Visitor who acts in this way will be removed for the remainder of show.

## SIFTING RULES

1. All animals will be sifted at weigh-in at the sifter's discretion. Decisions will be final. Sifted animals will be removed from the show barn and handled by show management. Animals may be sifted for the following reasons: crippled, diseased, external parasites, malnutrition, failure to meet the weight requirement, etc. The respective division Chairman will discuss the sifting protocol with the sifter.
2. Weighing Market Classes
  - a. All entries in the Market Classes (except Broilers) will be weighed on the grounds, by a committee, appointed by the management. This will be the official weight for all purposes.
  - b. Any re-weigh for animals must be called for immediately and must be done before the next animal is weighed. The animal will be held at the scale area until the scales have been cleaned and balanced and the animal's weight re-checked. If on the second weighing the animal does not reach the minimum weight or exceeds the maximum weight, the animal will be disqualified.
3. Show management reserves the right to sift unruly animals at any time during the show.

## SALE RULES

1. The auction will be held Monday, March 3rd at 4:30PM.
2. Sale of a maximum of 285 animals from the various market and carcass divisions will be based on a percentage of the total number of entries eligible to show. Sale to consist of animals to be determined by Auction and Records Committees. Each division chairman will have the opportunity to evaluate the Final Sale Order. **Any changes will need to be made before the sale sheet is sent to the printer at 11AM on Saturday of the show.**
3. The show management reserves the right to refuse the sale of any exhibitor's animal who breaks any rule of the show in any form.
4. All animals qualifying will be sold by the entry lot.
5. Exhibitors must be in line and ready to take the stage when their number is called. Failure to do so will result in a NO SALE. (NO LIVE ANIMALS ARE GOING TO BE PRESENTED ON AUCTION NIGHT.)
6. If an exhibitor's market/carcass animal makes the sale, he or she **MUST** sell their animal the day of the sale. If the exhibitor does not show up at the time the market animal/carcass is to be sold, then he or she forfeits their sale slot and is no longer eligible to exhibit any market/carcass animal in future Victoria Livestock Shows.
7. Each exhibitor must be present on the the sale stage unless authorized by show officials to have someone else stand in as a substitute.
8. Halter awards, ribbons and banners may be displayed in the auction stage. An exhibitor may carry a poster sized (22"x28") prop to promote his/her project.
9. No exhibitor can withdraw from the show or sale after the animal is weighed in and accepted for show.

10. An exhibitor is also eligible to sell one pen in the Commercial Heifer Sale. See JUNIOR COMMERCIAL HEIFER SHOW AND SALE rules.
11. MARKET DIVISION: An exhibitor can **raise** any number of steers, hogs, lambs, rabbits, goats, broilers, or turkeys or any combination of these in both market and carcass divisions. Rabbits, goats, boilers and turkeys are not eligible for the carcass division. Exhibitors can raise only 50 broilers.  
**An entry card and a fee must be submitted for each Market Division entered.**

*BREEDING DIVISION: Any number of heifers, gilts, ewes, and does may be raised for the breeding divisions. The breeding entries are not eligible for sale on auction night.*

**A.** The exhibitor can only **show** one market and one carcass entry per division, but they may show any number of divisions.  
*Note: The exhibitor is only allowed to sell one animal at the sale on Monday night.*

If an exhibitor is ineligible to show, no one else can show the animal for him/her. If an animal is sifted it is considered shown and no other species may be entered at that point. An online entry and a fee must be submitted for each Market Division entered.

**B.** If an exhibitor shows multiple live or carcass divisions and wins a sale slot in any two or more divisions the exhibitor will be required to choose which one (1) animal they want to sell. This decision is required to be made within thirty (30) minutes after the exhibitor's last sale eligible division show is concluded.

C. If an exhibitor with multiple division sale slots fails to submit their decision within the thirty (30) minutes time constraints after their last sale eligible division show the Auction Committee will sell the highest placing animal. If there is a tie placing animal, then the auction committee will flip a coin to decide which animal is selling. There will be no changes to the sale order after this decision.

D. All placings will remain the same regardless of any champion or multiple division sale slot not selling. Only live animals or carcass animals initially sale eligible will have a sale slot. There will be no moving into a sale slot after the division shows.

12. If an animal is sifted it is considered shown and no other species may be entered at that point.
13. Sale order will be posted by Saturday. **Any changes/corrections must be reported to the computer room by 11AM Saturday.** The show will not be responsible for any error after that time.
14. **VLS will be issuing all Exhibitor checks for the sale price of their market animal less the 4% commission fee. Checks will be picked up from the Extension Office. Exhibitors will receive in the mail or via email, a copy of the official Buyer Receipt. Checks will be ready for pick up the first week of May after the sale. All Exhibitors MUST bring a Thank-You note for each buyer in order to pick up his/her check.**

**PLEASE NOTE: Checks not picked up within 90 days will be voided and can be reissued by appointment only. THERE WILL BE A \$25 FEE FOR RE-ISSUING ANY EXHIBITOR CHECKS NOT PICKED UP WITHIN 90 DAYS.**

**ANY EXHIBITOR WHO FAILS TO PICK UP AND DEPOSIT THEIR CHECK ON OR BEFORE SEPTEMBER 1ST FOLLOWING THE VLS AUCTION, THEREBY RELINQUISHES THEIR CHECK TO VICTORIA LIVESTOCK SHOW AND SAID CHECK SHALL BE DEPOSITED INTO THE VICTORIA LIVESTOCK SHOW GENERAL FUND TO BE USED BY VICTORIA LIVESTOCK SHOW AS THE BOARD SO DETERMINES WITH NO ADDITIONAL RECOURSE BY THE EXHIBITOR. IF AN EXHIBITOR PICKS UP HIS/HER CHECK BUT FAILS TO DEPOSIT THE CHECK ON OR BEFORE SEPTEMBER 1ST, THE ISSUED CHECK WILL BE CANCELLED AND THE FUNDS SHALL BE DEPOSITED INTO THE VICTORIA LIVESTOCK SHOW GENERAL FUND TO BE USED BY VICTORIA LIVESTOCK SHOW AS THE BOARD SO DETERMINES WITH NO ADDITIONAL RECOURSE BY THE EXHIBITOR.**

**At the discretion of the Executive Committee, failure to follow these rules may result in the exhibitor not being able to participate in the Victoria Livestock Show the following year. If there are questions pertaining to the Sale, please contact the Auction Chairman immediately.**

## MARKET STEER RULES

1. Read General Rules.
2. Only one steer may be shown per exhibitor. Steer must be dehorned, halter broken, and fitted for the show. All steers must be ear tagged to compete in the show.
3. All steers to be eligible to show, must be tagged at major show validation in June. Watch for tagging dates and times in the 4-H newsletter or call your chairman/ag teacher. Tagging location will be at the Diebel Cattle Co. on Salem Road.  
NOTE: Tags for major shows must be ordered prior to these tagging dates through the AgriLife Extension Office.  
If an ear tag is lost, you must notify your supervisor immediately to have the calf retagged.

4. At show weigh-in, minimum weight is 1000 pounds.
5. There will be three (3) breed classifications with one or more weight classes in each breed at the discretion of show management. One entry will make a breed class.
  - a. American - Steers must exhibit at least 3/8 Brahman characteristics.
  - b. English - Steers must appear to be purebred Angus, Red Angus, Hereford, Polled Hereford, or Shorthorn.
  - c. All Other Breeds – All Steers which do not fall into the above classifications.
6. The sifter will have the authority to change breed classification of an entry. Should they feel that an animal does not meet the requirements, it will be placed in the All-Other-Breeds classification.

7. All steers' hair must be clipped to within one-quarter inch (1/4") except for the tail switch (tail switch being no more than 12-inches above the end of the cartilage of the tail).
8. Hair sifting will take place during Check-in & Sift. Exhibitors not meeting the hair sift will be allowed to remove their animal to a designated clipping area. They must be finished with their clipping and presented to the sifter for re-evaluation and admission to the show. No trim stalls are allowed for steer exhibitors.
9. No steers will be allowed to exercise, or otherwise move through unauthorized areas where commercial cattle or other species are stalled.
10. Drenching - Refer to # 16 under General Rules.
11. Seventy-five (75) percent of the market steers exhibited and placed will be allowed to sell, not to exceed twenty-five (25) head, or an equal percentage of all other livestock, whichever is greater. All three breed classifications will sell at least 75% up to four entries, after four entries in a breed the percent sold will be determined by the number of sale slots available. In order to sell at least 75% of the first four entries in each breed there must be at least twelve steers entered in the show. All NO SALE steers may be brought back for sale slot re-evaluation immediately following selection of Champion and Reserve Champion.
12. Only the exhibitor and ONE assistant will be allowed in the judging ring holding area.

13. All steers must be manageable by the exhibitor. The exhibitor must present their steer for evaluation. (No steer will be evaluated while tied to the rail.) Only the steer committee persons will assist the exhibitors with their animals while in the show ring. Any steer that becomes unruly or creates a disturbance will immediately be excused. THE SHOW MANAGEMENT WILL DECIDE IF THE STEER MAY RETURN TO THE RING OR BE REMOVED FROM THE SHOW. *Any unruly animals may be sifted at the discretion of the officials at any time during the show.*
14. Market classes with exhibitors who have already won a Grand Champion carcass or Reserve Grand Champion carcass will have an equal number of entries placed in that class. The additionally placed entries will only be eligible for the sale if the market division exhibitor decides to sell their Grand Champion carcass or Reserve Grand Champion carcass.
15. See schedule for release time of Non-Sale market steers. Final disposition of all non-sale Market Steers will be determined and reported to the Market Steer Chairman by the time of their release.

## MARKET HOG RULES

Read General Rules and refer to schedule for any important dates concerning market swine.

There will be five (6) breed classifications: (1) Duroc, (2) Hampshire, (3) Yorkshire, (4) Other Pure Breeds, and (5) Light Crossbreeds, (6) Dark Crossbreeds. In each breed classification, there will be weight classes to be decided after all entries are weighed in. Each class will contain a near equal number of hogs.

Classes will be divided as follows:

1 - 6 Hogs	1 weight class
7 - 12 Hogs	2 weight classes
13 - 60 Hogs	3 weight classes
61 + Hogs	4 weight classes

### GUIDELINES FOR PUREBRED HOGS

**BERKSHIRE** – The general color of Berkshires shall be black and white with erect ears. Must have white on face and tail, unless tail is docked. Three of the four legs must be white; may have occasional splash of white on the body.

INELIGIBLE:

1. Solid white or solid black face from the ears forward
2. Solid black nose (rim of nose)
3. Neither ear can be entirely white
4. Dropped ears
5. Formation of a belt encompassing part of the one-third front of the body

**CHESTER WHITE** – Solid white in color, no color on the skin larger than a silver dollar and no colored hair. Ears must be down and medium sized.

INELIGIBLE:

1. Erect ears
2. Animals with non-white skin pigmentation larger than



a silver dollar in one place

3. Animals with non-white hair

**DUROC** – Red in color. Must not have any white hair located on the animal. Ears down and medium sized. Must not have any black hair located on the animal. Maximum of three black spots on the skin and none of these spots can be larger than two inches in diameter. No shading or indication of a belt.

INELIGIBLE:

1. Black spots larger than two inches in diameter located anywhere on the body
2. Excessive dark pigment colored patches of skin or obvious shading of a belt on the forefront of the animal.

**POLAND CHINA** – Black with white face and switch (unless tail is docked). Three of the four legs must be white; may have occasional splash of white on body. Maximum of one white leg. Ears down. No evidence of belt formation. No red or sandy hair and/or pigment.

INELIGIBLE:

1. Animal that lacks breed character (erect ears, belt formation)
2. Animal that has red or sandy hair and/or pigment

**SPOTTED SWINE** – Black and white in color. Ears cannot be erect. No red tinted or sandy brown spots. No solid black head from ears forward. No distinct white belt pattern encircling and extending down and onto each shoulder.

INELIGIBLE:

1. Must not have brown or sandy coloration of any kind on the body
2. Solid black from ears forward
3. Must not have a combination of black leg and black foot
4. Very erect ears
5. A complete belt pattern encircling and extending down and onto each shoulder

## **HAMPSHIRE –**

### **IDEAL:**

1. Black in color with a full white belt over the shoulders encompassing both front legs/feet.
2. Possess Hampshire breed character with regards to skull shape.
3. Erect ears.

### **ACCEPTABLE:**

1. White belt starting on front foot/leg: belt partially encircles body extending to shoulder.
2. Freckling in the belt.

### **ABSOLUTE INELIGIBLE:**

1. White on forehead.
2. White skin extends over the rim of the nose.
3. When mouth is closed, the white under the chin cannot exceed what a quarter (.25) will cover.
4. Belt that extends past the sheath (sheath must be black).
5. Excessive frosting or white hair outside the belt.
6. Red hair.
7. Droopy or floppy ears.
8. Any evidence of physical tampering that would alter breed character.

**YORKSHIRE –** White in color. Ears must be erect. No hair color other than white. No colored skin pigmentation larger than a silver dollar. No masking above the eyes larger than a silver dollar.

### **INELIGIBLE:**

1. Any hair other than white located on any part of the body
2. Any non-white pigmentation spot larger than a quarter or total color spots larger than a silver dollar
3. Masking above the eyes
4. Floppy ears

**LIGHT CROSSBREEDS –** Any pigs with white and/or blue only.

**DARK CROSSBREDS** – All other colors (i.e. black, red, and sandy).  
Excluding solid white or blue.

1. The exhibitor must present the breed classification at the tagging date. The sifter will have the authority to change breed classification of any entry. Should they feel that an animal does not meet requirements, it will be placed in one of the above-mentioned classifications.
2. Barrows and gilts will be eligible for showing in the above classes.
3. Minimum weight is 220 pounds and maximum weight is 290 pounds. For re-weigh see General Rules or Sifting Rules.
4. No oils, paint, powder, or other dressing may be used on hogs. Only water can be used. The sifter will check each hog on weigh-in day. If any material is on the animal other than water during show day, the animal will be disqualified.
5. No canes or any abusive devices will be allowed for the purpose of showing market hogs.
6. Must have a VLS tag in pig's ear at all times unless the hog is major show tagged. Major Show tags will remain in the pig's ear throughout the show and not be replaced by VLS tag. Ear tags number must be clean and visible.
7. An exhibitor can enter as many market hogs as they want as long as each animal is tagged in a family name. Also, every possible exhibitor in the family must be named to the hog at the time of tagging. At weigh-in of the show, the exhibitor must designate one of the original entries to enter into the show. Hogs that are double entered (both market and carcass) must be brought in for market validation. Only one (1) entry fee is required per exhibitor.

8. If a hog loses its ear tag, the exhibitor has 24 hours to notify officials to get the tag replaced. Call Bruce Williams or Jennifer Gordon. They will re-tag the hog if no tampering or unethical practice has been exercised. If this is not done, the animal will be disqualified. No one is allowed to cut tags out of hog's ears except show officials.
9. Show management will furnish initial bedding in the Junior Division. Exhibitors must furnish additional bedding if needed.
10. Market classes with exhibitors who have already won a Grand Champion carcass or Reserve Grand Champion carcass will have an equal number of entries placed in that class. The additionally placed entries will only be eligible for the sale if the market division exhibitor decides to sell their Grand Champion carcass or Reserve Grand Champion carcass.
11. Exhibitors are responsible for their animals until removed by disposition or disposition representative. Refer to the General Rules Section.
12. Each exhibitor will be responsible for keeping their pen, aisle ways, and walking ring clean. Pickup manure in aisles and exercise arena when animals are out of pens.
13. Please keep the number of people at your pen during the judging to essential personnel only. This is to help YOU and all other exhibitors get their pigs to and from the show ring.
14. No mats will be allowed in the pens.
15. No spray bottles will be allowed in the holding pens during the show. Spray bottles will be provided for each pen by the Market Hog Committee.

16. By February 1st each exhibitor must let the Chairman know the number of swine they will be bringing. Example: 1 market & 1 breeding or the same animal for both.

## MARKET LAMB RULES

1. Read General Rules.
2. Only wether and ewe lambs will be eligible.
3. All lambs must be clean shorn not more than seven (7) days before the show. Lambs with over 1/4" wool will be sifted.
4. All lambs must be tattooed, and ear tagged to compete in the show. All sexually intact ewe lambs must have an official USDA Scrapie Eradication tag.
5. An exhibitor may enter as many market lambs as they want as long as each animal is tattooed and tagged to a specific family. At the weigh-in of the show, the exhibitor must designate one of the original entries to enter into the show.
6. If an ear tag is lost after the tagging dates, the market lamb Chairman must be notified within 24 hours. Contact: Kevin M. Janak 361-935-0560. He will re-tag the lamb if no tampering or unethical practice has been exercised.
7. Market lambs will not be checked for a full set of milk teeth.
8. There must be a minimum of four head to be considered a breed classification. There will be one or more weight class in each breed at the discretion of show management. (Fine Wool and Fine Wool Cross must be a cross with evidence of at least 50% Fine wool breeding.)
9. Minimum weight is 90 pounds. There is no maximum weight. All lambs underweight will be reweighed at that time. See General Rules pg. 10 or Sifting Rules pg. 15 (Sifting rule #1 will apply).
10. Drenching of market lambs with electrolytes for hydration

will be allowed. General Rule #15 applies.

11. Feeding in pens will not be allowed. Feed buckets must be kept in show boxes when not in use.
12. Market classes with exhibitors who have already won a Grand Champion Carcass or Reserve Grand Champion Carcass will have an equal number of entries placed in that class. The additionally placed entries will only be eligible for the sale if the market division exhibitor decides to sell their Grand Champion carcass or Reserve Grand Champion carcass.
13. Shearing/clipping will be allowed after check-in and the morning of the show. All clippings and hair are to be cleaned up immediately. No blocking of the aisles with equipment will be permitted. **All blocking tables and other equipment used to shear lambs must be removed immediately following the lamb judging.**
14. Pens will be pre-assigned per club/chapter.
15. Only the exhibitor and show officials will be allowed in the judging ring.
16. Halters are permitted in the judging ring for use by exhibitors if needed.
17. Exhibitors are expected to be ready to show when their class is called. Chairperson will not be accountable for finding the exhibitor. If you are not there when the gate is opened, you will not be allowed to show your lamb. Please be a responsible exhibitor.
18. Pickup manure in aisles and exercise arena when animals are out of pens.

## MARKET BROILER RULES

1. Read General Rules.
2. All 4-H and FFA youth intending to raise and show broilers at the Victoria Livestock Show must pay the entry fee and the cost of broilers online, see schedule for deadline.
3. Each exhibitor must order only 50 broilers.
4. All broilers will be ordered from one hatchery, will be of the same breeding and will be hatched the same day. The VLS Market Broiler Show will only consist of one division with pullets and cockerels showing in the same division. All 50 broilers will be banded and numbered as one group for a possible entry of three broilers or one entry. If a broiler loses a band or they are tampered with, the individual broiler is automatically disqualified from the show.
5. See schedule for date and time for Exhibitors or parents to pick up their day-old chicks at the **Victoria County 4-H Activity Center, 259 Bachelor Dr.**
6. Each exhibitor must select and show three Market Broilers for one complete entry. A complete entry consists of three Market Broiler Cockerels, three Market Broiler Pullets, or a combination of Market Broiler Cockerels and Pullets.
7. Each exhibitor must present their pen of three Market Broilers at the show. The exhibitor is allowed to provide one back-up market broiler at the time of the sift to present to the sift judge if one of the pens of three are not acceptable for show. Following the sift, exhibitors are required to remove the back-up market broilers from the exhibit barn.
8. A sifting committee, with the department Chairman as one member, will be appointed to inspect all entries for the purpose of eliminating any entry not in proper show



condition. Sick and diseased birds will be refused and if discovered during the sift, will be removed. Broilers losing their wing band for whatever reason will not be eligible to show. If the band and/or wing web shows evidence of tampering or if the wing web is torn in any way, the bird will be disqualified.

9. Each exhibitor is required to bring two one-pound coffee containers with a hole punched in the side next to the top of the can to be used for feed and water. All feed will be provided by the exhibitor. Litter will be furnished by the show.
10. Market Broilers will be shown by the exhibitor with the help of two other 4-H or FFA members, family members, or friends to hold the birds. It is the exhibitor's responsibility to find help before judging.
11. Market Broiler pens and the immediate area will be cleaned by the exhibitor daily.
12. No one will be allowed to handle the exhibitor's Market Broilers without the exhibitor's approval.
13. All Market Broilers must be removed from the show barn during the assigned release time on Sunday.
14. Exhibitors are responsible for delivering processed broilers to their buyer.
15. Exhibitors making the sale will present themselves and their placement ribbon during the auction.
16. Market classes with exhibitors who have already won a Grand Champion Carcass or Reserve Grand Champion Carcass will have an equal number of entries placed in that

class. The additionally placed entries will only be eligible for the sale if the market division exhibitor decides to sell their Grand Champion Carcass or Reserve Grand Champion Carcass.

## MARKET TURKEY SHOW

1. Read General Rules.

2. All 4-H and FFA youth intending to raise and show turkeys at the Victoria Livestock Show must pay the entry fee and the cost of turkeys online, see schedule for deadline. (Turkeys will be ordered through Victoria County 4-H Extension Office by August 1st; however, between October 1st and December 31st, to be eligible to show in the Victoria Livestock Show, you must enter your turkey through the VLS ShoWorks System.)

3. VLS will follow the rules for ordering outlined by Texas A&M Poultry Website under major shows. The number of birds allowed per exhibitor will follow the Major Show Order Limitation as outlined by Texas A&M Poultry Science department. All poultts will be wing banded and major show eligible birds will be ordered in lots of 25 straight run. Two exhibitors may "split" an order of turkey poultts - 12/13. These arrangements must be made between the exhibitors and then submitted in writing to the Victoria County Extension Office prior to the ordering deadline on the calendar and listed in Rules #2 & #4. Each exhibitor will also be responsible for entering their turkey in the the VLS ShoWorks System between October 1st and December 31st, to be eligible to show in the Victoria Livestock Show.)

4. Turkey Poult orders will be coordinated through Victoria County 4-H Extension Office. For current year's deadline for order time please see calendar of event in front of current rule book. All turkeys will be ordered from one hatchery, will be of the same breeding and will be hatched the same day. The VLS Market Turkey Show will only consist of one division. All 25 turkeys will be banded and numbered as one group. If a turkey loses a band or they are tampered with, the individual turkey is automatically disqualified from the show.

5. The date and time for Exhibitors or parents to pick up their day-old chicks will be coordinated through Victoria County 4-H Extension Office at the Victoria County 4-H Activity Center, 259 Bachelor Dr.

6. Each exhibitor must select and show one Market Turkey Hen for one complete entry.

7. Each exhibitor must present their Market Turkey at the show. The exhibitor is allowed to provide one back-up market turkey at the time of the sift to present to the sift judge if their turkey is not acceptable for show. Following the sift, exhibitors are required to remove the back-up market turkey from the exhibit barn.

8. A sifting committee, with the department Chairman as one member, will be appointed to inspect all entries for the purpose of eliminating any entry not in proper show condition. Sick and diseased birds will be refused and if discovered during the sift, will be removed. Turkeys losing their wing band for whatever reason will not be eligible to show. If the band and/or wing web shows evidence of tampering or if the wing web is torn in any way, the bird will be disqualified. The sifter and judge will disregard any wing damage caused by the required wing band.

9. Each exhibitor is required to bring two one-pound coffee containers with a hole punched in the side next to the top of the can to be used for feed and water. All feed will be provided by the exhibitor. Litter will be furnished by the show.

10. Market Turkeys will be shown by the exhibitor, and the exhibitor is responsible for holding the bird for judging.

11. Market Turkey pens and the immediate area will be cleaned by the exhibitor daily.

12. No one will be allowed to handle the exhibitor's Market Turkeys without the exhibitor's approval.

13. All Market Turkeys must be removed from the show barn during the assigned release time on Sunday. Refer to schedule and/or your chairman will relay the time once it is decided.

14. Exhibitors who have not deemed their turkey as PREMIUM are responsible for delivering processed turkeys to their buyer.

15. Exhibitors making the sale will present themselves and their placement ribbon during the auction.

## MARKET RABBIT RULES

1. Read all General Rules.
2. All Market Rabbits entered must be purebred, with or without pedigree papers.
3. See schedule for last day to withdraw market rabbits from VLS for refund.
4. Only commercial rabbits from the following breeds may be entered and shown: ARBA recognized six (6) class meat breeds of New Zealand (White, Red, Black, or Blue), Californians, Palominos, Satins (all ARBA recognized colors), Cinnamons, Crème D 'Argent, Champagne D 'Argent and Broken NZ.
5. Meat pen must consist of the same variety in the breed.
6. All Market Rabbits must be the bona fide property of the exhibitor. Rabbits to be validated for the market division show must be kindled (born) while in the possession of the exhibitor.
7. Exhibitors will be required to complete a Breeder Certificate with breeder contact information and signature. Breeder Certificate will be due at the 4H Activity Center, see schedule for time and date. In addition, all exhibitors and exhibitors' parents will be required to execute an affidavit to confirm compliance with show rule #6. This affidavit must be turned in at time of validation and tattooing, see schedule for date and time. Failure to comply with this show rule by the stated due dates will deem the exhibitor ineligible to show and a refund will be provided.
8. Exhibitors may purchase a bred doe. The target breeding date is 100 days prior to the show, with an ideal kindling date of 70 days prior to the show.

9. All exhibitors must provide their own equipment for feeding and watering their entry. Should it become necessary, exhibitors are responsible for the cooling of their rabbits. (Fans and frozen water bottles are permissible).
10. All water and feed storage containers must be removed from the cooping area after the animals are fed and watered.
11. Rabbit pens and the immediate area must be cleaned by the exhibitor before 9AM each morning.
12. An exhibitor may raise as many rabbits as they want and may be tattooed in a family name. Every possible exhibitor in the family must pay a separate entry fee. See schedule for date and time of validation and tattooing.
13. At the weigh-in of the show each exhibitor must designate 3 tattooed rabbits and one alternate, out of the rabbits originally validated to the exhibitor/family.
14. Market Rabbits will check-in on Wednesday at 11:00AM. **NOTE: Only exhibitors and Market Rabbit Chairman are allowed beyond the sifting gate.** Judging will be promptly at Noon.
15. All rabbits will be sifted at the time of check-in using the general standards as published by the "American Rabbit Breeders Association" (ARBA). The rules as set out in the "ARBA Standard of Perfection" are listed under "General Faults" and "Disqualifications from Competition". Weight limits: 3.5 lbs. minimum; 5.5 lbs. maximum **(which is an exception to the current ARBA weight rules for meat pens.)**
16. All rabbits will be judged by a certified ARBA Judge or a qualified ACTIVE rabbit breeder with 20 or more years experience, and will be judging on the ARBA point schedule for meat pens.

Complete narrative is available in the “ARBA Standard of Perfection”.

Meat	40 points

19. Exhibitors participating in Market Rabbit showmanship will be awarded based on the age divisions as published on page 84.

## MARKET GOAT RULES

1. Read General Rules.
2. All goats must be tagged to compete in the show. Entry fees are to be paid online before tagging. Goats may be validated by family name where more than one child in the immediate family is raising goats. All goats will be tagged with an ear tag furnished by VLS and tattooed in the opposite ear on tagging date. If a goat loses its ear tag, the exhibitor has 24 hours to notify Mike Tater to get the goat re-tagged. If this procedure is not followed, the animal will be disqualified. No one is allowed to cut tags out of the goat's ears except show officials. All sexually intact female goats must have an official USDA Scrapie Eradication Program identification ear tag. No other tags will be allowed in the goat's ears except VLS tags.
3. The show is open to any breed or crossbred meat goat type.
4. Only wethers or does that are not bred may be shown.
5. Market goats will not be checked for a full set of milk teeth.
6. Minimum weight at check-in is 65 pounds and maximum weight is 130 pounds. For re-weigh see General Rules pg. 10 or Sifting Rules pg. 15 (Sifting rule #1 will apply).
7. Exhibitors will be required to have the horns tipped blunt before arrival at check-in. Failure to do so will be grounds for sifting of the animal. Horns may be of any length.
8. Goats must be sheared slick (approximately 3/8 inch or less) above the knee and hock joints; excluding the switch, before arrival on the grounds. Blocking tables are permitted, but aisles must be free and passable. All tables and equipment must be removed following the judging.



9. If an animal has a health problem, it will be sifted. Sifter may consult with the veterinarian on duty.
10. Drenching of goats with electrolytes for hydration will be allowed. General Rule #16 applies.
11. Feeding in pens will not be allowed. Feed buckets must be kept in show boxes when not in use.
12. Weighing and assignment of weight classes will be determined under the direction of the goat Chairman.
13. Show management will furnish initial bedding in the Junior Division. Exhibitors must furnish additional bedding if needed.
14. Only the exhibitor and show officials will be allowed in the judging and sifting ring.
15. Halters are permitted in the judging ring for use by exhibitors if needed.
16. Exhibitors are expected to be ready to show when their class is called. Chairpersons will not be accountable for finding the exhibitor. If you are not there when the gate is opened, you will not be allowed to show your goat. Please be a responsible exhibitor.
17. Pickup manure in aisles and exercise arena when animals are out of pens.

## JUNIOR CARCASS DIVISION RULES

1. The Carcass Contest shall be governed by the general rules and regulations of the Victoria Livestock Show Associates.
2. An exhibitor may nominate more than one steer, wether or ewe lamb, gilt or barrow, in each division but only one animal may show in the carcass show. The animal shown must be validated to a specific family.
3. All animals weighing in at the carcass contest will be slaughtered at the Carcass Division packer or, if sifted, at the packer designated by the exhibitor.
4. An exhibitor may show one steer, lamb, or hog in the carcass show and one in the market show. However, only one of these animals may be sold at the Victoria Livestock Show Auction.
5. All animals must be clean for evaluation at check in prior to show. All steers must be halter broken and manageable by the exhibitor and one adult assistant.
6. **All exhibitors must be present for evaluation!**
7. See Schedule for carcass winners announcement. All participants are strongly encouraged to dress in the appropriate attire for this announcement.
8. An exhibitor can raise any number of steers, hogs, lambs, rabbits, or goats or any combination of these in both market and carcass divisions. Broilers, rabbits, and goats are not eligible for the carcass division. The exhibitor can only show one market and one carcass entry, and they may be of separate species. If an animal is sifted it is considered shown and no other species may be entered at that point.

An entry card and a fee must be submitted for each Market Division entered.

9. Junior exhibitors may sell only one entry in the Victoria Livestock Show Auction. All live animals placing high enough to make the sale will sell. An exhibitor who makes the sale with both live and carcass animals must sell their live animal. Exceptions being: Grand and Reserve Grand Champion carcasses will be sold instead of live animals. If an exhibitor exhibits a Grand and/or Reserve Grand Champion in both live and carcass divisions, that exhibitor will be given a choice of which animal will be sold. The decision must be made prior to the live animal leaving the show ring. All placing will remain the same regardless of any champion not selling.

## CARCASS STEER RULES

1. Read General Rules.
2. Steers must be born no earlier than October 1, 2023 (17 months prior to show). A signed breeder's statement verifying correct birth date of calf must be presented at registration to the Carcass Steer Chairman. Steers will be tagged with a VLS ear tag and weighed - for information only. Entry fee must be paid with registration and will be verified by Chairman.
3. Steers presented for Major Show registration and tagging can be nominated for the Junior Carcass competition under conditions that the exhibitor presents a signed breeder's statement of birth date validation upon registration. Steers will be tagged with a Major Show tag and weighed for information only on date determined for Major Show tagging.
4. All entries will be identified by ear tag. Should a steer lose its ear tag, the Carcass Steer Chairman (Russ Svetlik 361-935-5017) must be notified within 24 hours. Failure to promptly notify of tag loss or any evidence of ear tag tampering will disqualify the animal from the carcass contest.
5. See Schedule (page 5) for Carcass Steer check-in. Weighing of animals will begin at 5:30AM. **NO ENTRIES WILL BE ACCEPTED AFTER 6AM.** Minimum weight for check-in is 1000 lbs.
6. All animals must be de-horned or have loose horn scurs less than 1 inch in length. All steers must be halter-broken, clean for evaluation, and manageable by the exhibitor. Any unmanageable steers will be removed by the exhibitor.
7. The meat specialists check the validity of the steer carcass ages by standard bone and lean evaluation procedures. Steers exceeding a maximum of 900 lb. warm carcass weight will be disqualified from placing and ineligible to be sold in the VLS auction.

8. Steer carcasses will be ribbed between the 12th and 13th ribs. The judge will examine and record the following data in determining the carcasses USDA Yield Grade:

WARM CARCASS WEIGHT (LBS) RIBEYE AREA (SQ. IN.)

KIDNEY, PELVIC & HEART FAT (%)

FAT THICKNESS OPPOSITE RIBEYE (IN.)

PRELIMINARY YIELD GRADE (Based on estimate of overall fat cover) Yield Grade will be calculated using the following formula:

USDA Yield Grade =  $2.50 + (2.5 \times \text{adjusted fat thickness, inches}) + (0.20 \times \% \text{ kidney, pelvic \& heart fat}) + (0.0038 \times \text{warm carcass weight, lbs.}) - (0.32 \times \text{rib eye area, square inches})$ .

9. The judge will determine carcass Quality Grade with the following categories:

PRIME (PR+, PR, PR-)

CHOICE (CH+, CH, CH-)

SELECT (SE+, SE, SE-)

STANDARD (STD+, STD-)

10. Any STANDARD Quality Grade steers will be disqualified from placing and will not sell in the VLS auction. Exhibitors will be notified prior to the contest placing.
11. Carcasses exhibiting the following deficiencies in the judges' discretion will be subject to applied adjustments for appropriate order of placing:

DEFICIENCY

CARCASS WT < 550 LBS

RIBEYE FAT THICKNESS < .25 IN. "DARK CUTTER"

APPEARANCE

12. The judge will place all qualified carcasses and rank them by accepted beef industry standards used in determining individual carcass value. The most desirable carcasses will exhibit the following:

Quality and Yield Grade characteristics:

<u>QUALITY GRADE</u>	<u>YIELDGRADE</u>
PRIME	<4.0
CHOICE	<3.5
SELECT	<3.0

13. Carcasses placing 1st through 12th place will be transported to a local processing facility and will be available to the respective auction buyer for processing through same facility.
14. Those carcasses above 12th place will not be available to the exhibitor. These carcasses will have final disposition through the processor and sold through their facility at reasonable value for the beef market conditions at the time of the show, per agreement by VLS management, payable to VLS. These carcasses above 12th place which are eligible for the VLS Auction per VLS Auction determination procedures, will be sold in the VLS Auction as “resale” only.
15. Carcass Exhibitors determined as not eligible for the VLS Auction will receive resale checks from VLS for all carcasses above 12th place equal to the amount received as fair market value from the processor.

16. All 1st thru 12th place steers not eligible for the VLS Auction are the responsibility of the exhibitor for disposition through the local processing facility.

All carcasses will be identified by tag number or VLS Sale number.

Any carcasses not claimed after 2 weeks following the show will become property of the processor.

17. All correspondence with the processing facility concerning any carcass entered into the VLS Carcass Steer competition will be directed through VLS management.

## CARCASS HOG RULES

1. Read General Rules.
2. Entry fees must be paid online. Hogs desired to be entered only in the carcass division must be brought in, and the ear tag number must be listed on the nomination form. Hogs that are double entered (carcass & market) are required to be brought in for market show nomination.
3. All entries will be identified by a Victoria Livestock Show ear tag. Ear tags number **MUST** be clean and readable at weigh in. Hogs without an ear tag will not be unloaded from trailer at weigh-in. The Carcass Hog Chairman must be notified within 24 hours should a hog lose its ear tag. Failure to do so will eliminate the hog from the carcass show. Contact Larry Frederick - 361-649-8503.
4. See schedule for entry time and date. Barrows and gilts will be evaluated. **NO LATE ENTRIES WILL BE ACCEPTED.**
5. Minimum weight is 230 pounds and maximum weight is 280 pounds. Any re-weigh of an animal must be called for immediately. For re-weigh see General Rules or Sifting Rules. Unsound and stress symptom hogs will be sifted.
6. Only the Grand and Reserve Grand Champions will be brought back to the VLS. All buyers at the VLS Auction and exhibitors that are not eligible for the auction will receive resale checks only.
7. All ear tags must be clean and readable at weigh-in.
8. The objective of the carcass hog contest is to select the kind of carcass that is desirable to all segments of the meat industry. Therefore, carcasses eligible for placing must meet the following minimum requirements:
  - a. Processor to remove the head before weight is taken. The warm carcass weight minimum/maximum shall be



167/229 pounds. This is based on pork processor Hormel's 2010 buyer's grid

- b. USDA Grade #1 hogs
- c. Minimum average carcass back fat thickness, .7 inch
- d. Maximum back fat thickness at the last rib, 1.24 inches
- e. Minimum carcass muscling score of 2.0 as illustrated in the 2002 Pork Composition and Quality Assessment Procedures (NPPC, Des Moines, IA).

Carcasses will be evaluated for meat quality by visually appraising the loin muscle, color, marbling, and firmness as well as other abnormalities (soft and oily fat; pale, soft and watery lean; dark, firm and dry lean). Carcasses failing to meet two or more of the acceptable range requirements as outlined on the current Pork Composition and Quality Assessment Procedures (NPPC, Des Moines, IA) will be disqualified for placing.

Carcasses meeting the above minimum requirements will be evaluated for the percentage of fat-free lean by the following National Pork Producers Council formula:

Percentage of fat-free lean equals  $[(8.588 - (21.896 \times \text{the 10th rib fat depth, in.}) + (3.005 \times \text{10th rib loin muscle area, in}^2) + (0.465 \times \text{warm carcass weight, lbs.})) / \text{warm carcass weight, lbs.}] \times 100$ . Carcasses will be ranked on percentage of fat-free lean. Final carcass placing will be made at the discretion of the carcass judge based on overall carcass merit.

- 9. An exhibitor can nominate as many carcass hogs as they want as long as each animal has a signed entry card and is tagged to a specific family.

## CARCASS LAMB RULES

1. Read General Rules.
2. Entry fees must be paid online.
3. All entries will be identified by a VLS ear tag and tattoo. The Carcass Lamb Chairman must be notified within 24 hours should a lamb lose its ear tag. Failure to do so will eliminate the lamb from the carcass show. Contact Jerry Leita at (361) 550-3319.
4. All sexually intact female lambs must have an official USDA Scrapie Eradication Identification ear tag.
5. See schedule for date and time for entries to weigh-in. Wether and ewe lambs will be eligible. **NO LATE ENTRIES WILL BE ACCEPTED AFTER THE LATE DEADLINE.**
6. Lambs must weigh 90 lbs. minimum to 135 lbs. maximum. They must be shorn to ¼" of wool or less.
7. The objective of the carcass lamb contest is to select the kind of carcass that is acceptable to all segments of the meat industry. The judge will place the carcasses on the basis of quantitative yield of the preferred cuts, quality of the carcass, size of the rib eye and thickness and completeness of subcutaneous fat cover.
8. The ideal lamb carcass:
  - a. Has a bright, attractive color of lean.
  - b. Has a quality grade of USDA Choice.
  - c. Has large rib eye.
  - d. Is at least slightly, but completely covered with external (subcutaneous) fat.
  - e. Has a minimum fat thickness over the center of the rib eye of .10 inch and maximum of .25 an inch.
9. All carcasses will be ribbed between the 12th and 13th ribs

according to the approved practice established by the American Meat Science Association. The rib eye area and thickness of fat over the center of the rib eye will be measured. The rib eye muscle will be evaluated for marbling, color, firmness, and texture.

10. Carcasses must have 0.10 inch - 0.25-inch adjusted fat cover over the rib eye and must grade U.S. Low Choice or better to be eligible for placing.
11. Lambs with a maximum warm weight exceeding 80 lbs. will be disqualified.
12. Carcass lambs will be placed based on the following two formulas:
  - a. Yield Grade =  $0.4 + (10 \times \text{adjusted fat thickness, inches})$
  - b. % Boneless closely trimmed retail cuts =  $49.936 - (0.0848 \times \text{warm carcass weight, lbs.}) - (4.376 \times \text{adjusted fat thickness, inches}) - (3.530 \times \text{body wall thickness, inches}) + (2.456 \times \text{rib eye area, square inches})$
  - c. Final carcasses placing will be made at the discretion of the carcass judge based on overall carcass merit.
13. The Grand and Reserve Champion Carcasses will be brought to VLS and hung in the carcass cooler as in the past.
14. All buyers at the VLS Auction and any exhibitors that do not make the sale will receive resale checks only.

## BREEDING DIVISION RULES

1. Read General Rules.
2. Online entries must be submitted for the Junior Breeding Heifer Show, Junior Breeding Bull Show, Junior Breeding Ewe and Doe, and the Junior Breeding Gilt Show.
3. Breeding Rabbit entries will be registered and paid the morning of the show.

## JUNIOR BREEDING BEEF - HEIFER SHOW

1. Read General Rules.
2. Animals must be registered with the parent breed association. AOB and ABC heifers may be shown if certified by the TCCA and have official TCCA AOB or ABC ear tag and certificate number. Each animal must be registered in the name of the individual exhibitor. Only bona fide members of Victoria County 4-H Clubs or FFA Chapters are eligible.
3. All animals must be owned, in possession and registered in the name of the exhibitor by the parent association on or before October 31, 2024. No Heifers older than 9-1-22.
4. All heifer breed division classes will be set up as follows: There will be a minimum of two heifers per breed division. Breeds with less than two animals will go to American/Brahman or "Other Breeds" division. Number of entries may warrant a division in classes. Classes may then be divided according to age. This decision will be at the discretion of the division Chairman.
5. Overall Champion Class - Each division will be represented by their Champion and Reserve Champion. These heifers will be judged and placed as follows: Grand Champion Overall and Reserve Grand Champion Overall.
6. Total placing will depend on number of divisions.
7. Banners will be presented to the overall Grand Champion and to the Reserve Grand Champion. One banner to the exhibitor and a like banner to the breeder will be presented. Premium money will be paid as follows:

Grand Champion Heifer of the Show - 31.25% of the

premium money raised not to exceed the sum of \$500.00.  
Reserve Grand Champion Heifer - 25% of the premium  
money raised not to exceed the sum of \$400.00.

8. Any entry that becomes unruly or creates a disturbance in the show ring will immediately be excused at the discretion and instruction of the ring steward and will not be eligible to compete.
  
9. The Junior Breeding Beef Heifer Show will follow the Bull Show beginning at 9AM on Saturday.

## JUNIOR BREEDING BEEF - BULL SHOW

1. Each animal must be registered with the parent breed association in the name of the 4-H or FFA individual exhibitor by October 31, 2024.
2. All bulls must be halter-broke and the exhibitor must be able to handle the bull themselves. If not, they may be deemed unruly and excused for the show at discretion of the committee.
3. All bulls are required to be shown with a nose ring that is attached to a lead. Bulls over 11 months must have a permanent nose ring.
4. All bulls that have horns exceeding 6 inches or greater must be tipped.
5. There will be 2 classes of bulls in each of the 3 divisions.  
(A Division will consist of 2 bulls or greater.)
  - a. American Division / British Division / Exotic Division
    - i. Class 1 – ages 12 months or less
    - ii. Class 2 – ages 24 months or less
6. The Junior Breeding Bull Show will be at 9AM on Saturday.

**JUNIOR COMMERCIAL BREEDING HEIFERS**  
(Halter Commercial Heifers)

1. All heifers will be validated with a VLS ear tag annually during the October state heifer validation at Diebel Ranch. All heifers from the previous year must be re-validated for the new show year.
2. There will be no limit to the number of heifers an exhibitor can validate or show.
3. Crossbred females are desired, but purebred females will be permitted. You CAN NOT cross enter between the commercial heifer show and the JR breeding registered show.
4. All cattle MUST be halter broke and dehorned
5. All heifers will be weighed and classified at the show during the steer weigh-in and classification.
6. The exhibitor will show in their respective weight and breed classification.

**Divisions**

- a. Brahman-Cross- must have physical evidence (75%) of Brahman background to include ear length, shape and amount of hide and hump/crest.
  - b. American- anything NOT in the Brahman cross, with at least 50% of Brahman characteristics.
  - c. British- heifers must appear to be purebred Angus, Red Angus, Hereford, Polled Hereford or Shorthorn.
  - d. Exotic- all heifers that do not fall into the other breed classifications.
7. Placing class ribbons will be awarded along with division grand and reserve rosettes and grand and reserve supreme heifer will be awarded a banner and jacket certificate.

## JUNIOR COMMERCIAL HEIFER SHOW AND SALE

The purpose of the Commercial Heifer Show and Sale is to provide a project that will expose the exhibitors to commercial cattle production, as well as learn and share their knowledge about important elements of the beef industry. This includes the purchasing, development, breeding, exhibition, and marketing of crossbred beef heifers.

This project is not part of the Junior Livestock Auction Division. Therefore, 4-H and FFA members can sell in this program as well as the Junior Livestock auction. However, exhibitors must abide by the General Junior Livestock Rules.

1. This show is limited to projects owned, fed and cared for by Victoria County 4-H and FFA members in good standing and under the supervision of the Agriculture Science Teachers and County Extension Agents.
2. The Junior Commercial Heifer Show and Sale is an opportunity to show and sell commercial heifers. Crossbred heifers are desired, but purebred heifers will be permitted to show. Any heifer exhibited in the Commercial Heifer Show will not be allowed to compete in any other Junior Beef Heifer Show of the Victoria Livestock Show.
3. A maximum of three (3) head may be tagged in. Each exhibitor may tag in one alternate heifer; only two head will be allowed to compete in the show and sale. If a heifer is unable to compete and the exhibitor has only one (1) remaining heifer, that single heifer will be able to sell in the sale but will be ineligible to compete for awards or prize money. In the event there are an excess of 100 entries in the Commercial Heifer Show and Sale, the Commercial Heifer Committee reserves the right to sift single entries.
4. All junior commercial heifer entries will be tagged at Briggs Ranch, see schedule for date and time. Each exhibitor must

register on-line and pay the entry fee of \$50.00 per pen. Each exhibitor is limited to one pen of heifers.

5. All heifers must be Brucellosis calfhooed vaccinated by the initial tag in. They must have a legible brucellosis calfhooed vaccination tattoo.
6. Heifers cannot be added or switched after the tag-in date.
7. Exhibitor must own heifers 100% throughout the feeding period starting on the initial tag-in date.
8. See show schedule for check-in. The commercial heifer show will take place at the Victoria Livestock Show Pavilion.
9. All heifers must comply with Texas Animal Health Commission Rules governing entry into Victoria County Livestock Show grounds. All heifers must have a health certificate and be palpated by a licensed veterinarian. The health certificate should state open, exposed, bred (months) or calf at side.
10. Judging Guidelines and Selection for heifers:
  - a. Quality, confirmation and condition 30 pts
  - b. Structural soundness 15 pts
  - c. Frame size for age 15 pts
  - d. Reproductive soundness 10 pts
  - e. Area adaptability 10 pts
  - f. Uniformity 10 pts
  - g. Temperament 5 pts
  - h. Presentation of project 5 pts
  - i. Bonus - Calf at side TBD
11. Premiums will be established by the Junior Commercial Heifer Show and Sale committee. Prize money will be awarded according to monies available for judging animals.

12. All heifers that pass sifting and grading must sell as scheduled. Buyers will make a check to Victoria Livestock Show for the total of all heifers purchased.
13. VLS will make a check payable to the exhibitors for sale price of heifers, less the 6% commission fee and less the \$2.00/head Beef Check-Off fee. All checks will be available approximately 10 days after the sale.
14. All heifers will be released the day after the sale between 8AM-11AM.
15. The Commercial Heifer Committee reserves the right to amend these rules with the approval of the Victoria Livestock Show Board.
16. All heifers entered in this program and sold, remain the property of the exhibitor until leaving the show grounds.
17. There will be no harassment of the judges, committees, or show board prior to, during, or after the sale.
18. This program is designed to be educational and beneficial to the youth of Victoria County. Any parent or exhibitor found not adhering to any rules pertaining to the Commercial Heifer Show will have their entire family banned for a period of one year to lifetime from exhibition in the program per the Commercial Heifer Committee's discretion.
19. Heifer Classes:
  - Class I – Spring born  
1/1/24 to 3/31/24 Heifers must be open on the day of Commercial Heifer Show check-in.
  
  - Class II – Fall Females  
7/1/23 to 12/31/23 May be exposed no earlier than November 15, 2024.

Heifers can be no more than 120 days pregnant at the day of the Commercial Heifer Show check-in.

Class III – Spring born 2 years old

1/1/23 to 6/30/23 Entries must have calf at side or be palpated heavy bred (third trimester)

Champions from Classes I, II, and III will show for Grand Champion and Reserve Champion of the Show. Judging results will be announced Friday, February 21st at 6:00PM.

20. Judging will take place on Friday, Feb. 21st at 8AM. All cattle will need to be fed and pens cleaned prior. No signs will be allowed on the pens during judging.
21. **Record books are mandatory for all exhibitors and are due February 1st-7th and turned in at the Agrilife Extension office. Records books will be judged.**
22. Commercial heifer interviews will be optional. The interview details and schedule will be available by January 15th once sign-up is complete.

## JUNIOR BREEDING GILT SHOW

1. All entries and awards in the Junior Breeding Gilt Show will be subject to the General Rules and Regulations published in the Rule Book.
2. Fee is \$35 per entry.
3. Market gilt hogs may be entered into the breeding gilt show with an additional \$35 fee.
4. All entries for the Junior Breeding Gilt show must be entered online. See the general rules for entry deadline and online entry instructions. If entering Registered Breed gilts, the breed type, and date of birth must be provided with the online entry.
5. An exhibitor may only enter one gilt per individual class.
6. The Junior Breeding Gilt Show will consist of Registered Breed classifications and Crossbred gilts.
  - a. Six (6) gilts will be needed to make a Registered Breed Classification, based on entries.
  - b. Registered Breeds represented by less than six (6) gilts will be combined as Other Pure Breeds (OPB).
  - c. If needed, OPB divisions may be split into White and Dark Breeds.
  - d. Crossbred gilts will be classed by weight division. Weight Classes are 230 and under, 231 - 250, 251 - 270, and 271 and above.  
\*\*Large classes may be split into equal sub-classes.
  - e. The original certificate of registry is required for all Registered Breed gilts. A copy may be accepted if the gilt is the award of a scramble certificate and the copy includes the official stamp of the associated show holding the original. *Registration papers must be provided at weigh-in.*
7. Crossbred gilts are not eligible to compete for grand and reserve champion of the Junior Breeding Gilt Show.

8. Any gilt which is not registered in the name of the exhibitor on or before the deadline listed in the general rules schedule, will be assigned to the crossbred class. No fresh ear notches will be permitted. Registered Breed gilts with ear notches not matching the registry certificate may only be shown in the crossbred class.
9. Health requirements will be under current regulations of the Texas Animal Commission.
10. Breeding Gilts will unload at the barn from 3PM-5PM on Wednesday alongside the market hogs. Weigh-in for Crossbreds and Registration paper checks for Registered Gilts will begin at 5PM-7PM on Wednesday. Exhibitors are required to be present at check-in/ weigh-in. Exhibitors with Registered Gilts will need to have their papers in-hand and wait at their pen from 5PM-7PM. A team of committee members will come by and collect registration papers and confirm ear notches.
12. Junior breeding gilt judging will be Friday at 8AM. Exhibitors are required to be in the main arena bleachers 30 minutes prior to judging.
13. Any exhibitor not in the pen area during sweepstakes judging will forfeit all monies won.
14. Sweepstakes maximums will be \$500.00. Additional places will be paid as money is available.
15. Crossbred gilts will be eligible for all awards from third place down.
16. An exhibitor may be awarded no more than one sweepstakes money.
17. Gilts must be clean and clipped prior to arrival. No clipping allowed on show grounds. Dressings: No oil, paint, powder or other dressing is permitted on gilts. Only water is allowed.

18. Pens should be kept clean and animals are to be cared for at least twice daily. Exhibitors are not allowed to feed gilts during judging.
19. Only pig water dispensers are allowed to remain in the pens during the show. Unless attached to the water dispenser, feed pans must be removed. All feed will be removed out of the pens ten minutes prior to judging.
20. ONLY exhibitors, Committee members and approved elected team leaders are allowed in the pen area during the judging.
21. ONLY JUNIOR BREEDING GILT EXHIBITORS MAY SHOW BREEDING GILTS.
22. The intent of the Junior Breeding Gilt show format is to encourage youth to take lead in their project. To reduce distractions and interruptions, please encourage family and friends to watch from the bleachers.
23. Release time will be Sunday starting at 7AM.  
Premiums will be paid as money allows. Premium checks will be handed out at 6:30AM Sunday before release.  
*3 THANK-YOU CARDS ARE DUE AT THIS TIME.*
24. Each exhibitor must turn in Thank You cards to send to our donors. (3 thank you cards per exhibitor.) Exhibitors will not receive their premium check or animal release until that exhibitor's Thank You cards have been turned in. Please leave envelopes unsealed with nothing written on the outside of the envelope. The chairman will be responsible for mailing the Thank You notes to all donors for the Jr. Breeding Gilt Show.
25. By February 1st each exhibitor must let the Chairman know the number of swine they will be bringing. Example: 1 market & 1 breeding or the same animal for both.

## BREEDING EWE SHOW

All General Rules of the Victoria Livestock show will apply to this show.

1. All Ewes will be state validated and required to have a state breeder/USDA scrapie tag. All ear tags and tattoos will be checked .

Exhibitors may validate and enter as many breeding ewes as desired. If more than one ewe is in a class per same exhibitor, another exhibitor can show.

Exhibitors with Market Lambs and Breeding Ewes will stall/pen together.

If exhibitors entered a ewe in the market show they may enter the breeding show with the same animal, if the animal meets all other breeding rule criteria. Both entries must be entered and paid online.
2. Ewes will be broke into divisions of breed then by the tooth rule. Teeth and age will be checked by a vet on the day of check in. Classes will be broke down by weight.

Ewe lambs must be carrying all milk teeth at time of check in. Ewes carrying at least two permanent incisors at time of check in will compete in a two tooth/yearling division.

Ewes carrying more than two permanent incisors will compete in the mature class.

Classes will be shown according to the divisions, single class entries will only show in the drive.
3. Commercial and registered will show together in their respective breeds. Must have two sheep to constitute a breed.

Breeds that can be shown: Southdown, Dorper, Fine Wool, Fine Wool Cross, and Medium Wool.

We will not have a classifier, however Breeding Ewe Committee will have final say in classification. Entries will be classified at validation and again when registering on Show Works.

4. Ewes must be slick shorn with no leg shag above the knee.  
Lambs may not have wool longer than ¼ inch and must be shorn before the show.

Blocking tables, blowers and clippers are allowed at show for touch up and fitting only.

**Awards:** Grand and Reserve overall will receive buckles and banners. Division champions and reserve will receive banners. Classes will receive ribbons.

## BREEDING DOE SHOW

All General Rules of the Victoria Livestock show will apply to this show.

1. All does will be state validated and required to have a state breeder/USDA scrapie tag. All ear tags and tattoos will be checked .  
Exhibitors may validate and enter as many breeding does as desired. If more than one ewe is in a class per same exhibitor, another exhibitor can show.  
Exhibitors with Market goats and Breeding does will stall/pen together.  
If exhibitors entered a doe in the market show they may enter the breeding show with the same animal, if the animal meets all other breeding rule criteria. Both entries must be entered and paid online.
2. Does will be aged and classed according to the tooth rule. Teeth and age will be checked by a vet on the day of check in. Classes will be broke down by weight.  
Doe kids must be carrying all milk teeth at time of check in. Does carrying at least two permanent incisors at time of check in will compete in a two tooth/yearling division.  
Does carrying more than two permanent incisors will compete in the mature class.  
Classes will be shown according to the divisions, single class entries will only show in the drive.
3. Commercial and registered boer goats will show together.
4. Does may be fitted or blocked to exhibitors discretion. Blocking tables, blowers and clippers are allowed at show for touch up and fitting only.

**Awards:** Grand and Reserve overall will receive buckles and banners. Division champions and reserve will receive banners. Classes will receive ribbons.

## PONY SHOW RULES

1. As a minimum requirement, all ponies 50" and under, must be serviceably sound for show purposes. A regulation measuring stick is available for any questions on the height of any pony. Measurement is at withers. Any pony showing evidence of lameness, deformity in feet, broken wind or complete loss of sight in either or both eyes shall be disqualified.
2. Ponies may be of any color, either solid or mixed. No color is preferred, nor is any color to be considered undesirable, nor should discrimination be made because of the color of the eyes, such as glass, witch hazel, or blue.
3. Ponies should be neatly trimmed, well groomed, and attractively presented to their breed standard in the show ring. Ponies must have a full mane and tail with a bridle path.
4. All halter classes, with the exception of miniatures, will work off the rail, a tailer can be used if needed.
5. Any handler found to be abusing an animal or any exhibitor found to be disruptive to the show procedures in or out of the ring is to be automatically excused from the show along with the animal. Any animal endangering another animal or exhibitor will be excused from the ring by the judge, ring steward or Pony Chairman.
6. All parents and exhibitors must sign a code of conduct at the time of entry in order to show in the Victoria Livestock Show Pony Show.
7. The Pony Chairman or Assistants will be fully responsible for the interpretation and adherence to the show rules. The

Chairman will have the authority to make any decisions relative to these rules and policies. The Chairman will have the full authority to disqualify an entry who fails to conform to the policies and rules.

8. NO stallions allowed at the Victoria Livestock show. Exhibitors 6 and under should be accompanied by an assistant. The assistant is to let the exhibitor work and set up the pony on their own. No assistant is allowed to hold the pony unless the pony becomes unruly.
9. Entry forms should carry the year of birth of each pony using January 1st as the birthday. The exhibitor's ages are to be as of January 1st of the current year.
10. A pony currently involved with or supervised by a person should not be judged by that individual.
11. All ponies must have a current Coggins and the Coggins must be shown at check-in.
12. For showmanship, the exhibitor must wear long sleeved shirt, jeans, hat, boots, belt and neckwear. And hair should be neatly pulled back out of the face.
13. In the trail and jumping classes all exhibitors must stay on course, if the exhibitor goes off course it will result in a disqualification from the class. The exhibitor is only allowed to show one pony in the "in hand" classes.
14. We will offer "Cool" classes for the physically/mentally handicap youth of the community.
15. No refunds for entries will be made.
16. The exhibitor will be called twice. After the second call, you will not be allowed to enter the ring with your pony.

17. If a tack or pony change is needed, please make sure the gate attendant is aware so that a hold can be put on the class.
18. Only exhibitors and their parents will be allowed in the pony staging/holding area. All children under the age of 6 must always be supervised by an adult (an adult is any individual over the age of 18 years old).
19. You do not have to be a member of the South Texas Shetland Pony Club of the show, but in order to receive points towards the end of the year awards; you must be a current member in good standing, turn in your sponsorship by the deadline date, and attend 3 out of the 4 shows.
20. Two awards will be given at the show; the Audrey Barrett Sportsmanship Award and the Judges Choice Award.
  - a. The **Audrey Barrett Sportsmanship Award** will be given to an outstanding youth that shows excellent Sportsmanship thru the duration of the show. The award is in remembrance of the late Audrey Barrett, she was the founder of the club and show.
  - b. The **Judges Choice Award** will be given to the youth that stands out to the judge that day.
21. We are responsible for setting up and taking down our arena and staging area. We ask that each exhibitor and parent commit to helping with either the set up or take down. Each exhibitor present will receive 1 point towards the end of the year awards. It is the responsibility of the exhibitor to sign in for points.

## COUNTY FAIR

### HOMEMAKING DIVISION

1. All general rules of the Victoria Livestock Show will apply to this division.
2. Schedule:
  - a. Pre-registration opens on Showworks January 1 - February 16, 2025.
  - b. CHECK-IN: Wednesday, February 26 from 5PM-7PM OR Thursday, February 27 from 7:00AM-9:00AM in the VLS Hall
  - c. Judging will be Friday, Feb. 28th from 8:30AM-NOON.
  - d. Public Viewing: Friday, February 28 from 1PM-7PM and Saturday, March 1 from 10AM-NOON.
  - e. Buy Me Now Market Sale (non-Auction items) - Saturday, March 1 from 10AM-NOON.
  - f. **Pick up Projects** – Friday, February 28 starting at 1:00PM through Saturday, March 1 ending at 2:00PM in VLS Hall. All items **MUST** be picked up before 2:00PM Saturday.
  - g. Silent Auction – Monday, March 3 at 4:00PM-8:00PM inside the Victoria Community Center Dome. Items must be checked in on this day from 3PM-4PM.
3. Requirements:
  - a. Entry is open to any resident of Victoria County.
  - b. Entry must have been made within the current year (ex: Feb. 2024 to Feb. 2025) and be the work of the exhibitor.
  - c. Any items previously exhibited in the County Fair, with the exception of the Food Division, will not be accepted
4. Registration:
  - a. Exhibitors are required to pre-register on ShoWorks. **NO WALK-INS WILL BE ALLOWED.**
  - b. Entry cards and summary sheets will be provided at the time of check in.
  - c. Exhibitors are allowed to enter only one item per class per division.



5. Judging:

- a. NO ONE other than the judges and approved committee members will be allowed in the exhibit area during the time of judging. ALL DOORS WILL BE LOCKED.
- b. The show officials and judges can determine the final appropriate classification for the entry.
- c. All entries are subject to disqualification. Any rule not followed by the exhibitor will lead to an automatic disqualification and not be judged. Judges and show officials' decisions are final.

6. Awards:

- a. In each class, a Blue, Red, or White quality of work ribbon will be given to the top three entries. There will be no participation ribbons given out.
- b. In each division, a Grand and Reserve Grand Champion item will be named in each respective age group.
- c. All Grand Champion items will then be judged for a "Best of Show" in each respective age group.

7. Silent and LIVE Auction:

- a. Only 4-H and FFA exhibitors qualify for the silent auction. *ADULT and non-4-H/FFA members are NOT eligible for the silent auction.*
- b. YOUTH Grand Champions, YOUTH Reserve Grand Champions and YOUTH Best of Show winners' entries will be auctioned off, if approved by the exhibitor.
- c. Youth Senior (9th-12th grade) Best of Show Winner will be included in the LIVE Auction on Monday night with no cash limit. Senior must be an active member in FFA or 4-H and will follow the 7 point system.
- d. Minimum bids will be placed on all entries for silent auction.
- e. All food entries eligible for the auction must be remade fresh for the buyer, excluding unopened cans, jars and bottles.
- f. All auction monies will go directly to the exhibitor.
- g. A Thank-You card must be submitted to the Victoria 4-H Extension Office in order to receive exhibitor's check.

8. Pick Up:
  - a. All entries must be picked up by the designated time.  
**ALL ITEMS NOT PICKED UP ON TIME WILL BE DISPOSED  
UNLESS OTHER ARRANGEMENTS HAVE BEEN MADE.**
9. The Victoria Livestock Show and County Fair will take all reasonable precautions for items exhibited, however, will not assume responsibility for any items lost, damaged or stolen.
10. The age categories for competition will be as follows
  - a. Clover Kids (PreK – 2nd grade)
  - b. Junior (3rd - 5th grade)
  - c. Intermediate (6th - 8th grade)
  - d. Senior (9th - 12th grade)
  - e. Adult
11. Entry fee is \$5 per item.
12. Divisions and classes
  - a. A person may enter only ONE item per class.
  - b. All entries MUST be the original work of the exhibitor.
  - c. Please see each Division for additional specific rules.

## **ARTS DIVISION**

Art may be matted or framed but use of glass is NOT allowed. 2D Art must have a hanger attached securely to the back (wire, string, pipe cleaners, etc with tape, glue, etc) for display and may not exceed 24"x36" (including a mat). 3D art must be sturdy enough for transport and easily moved.

1. PAINTING – includes any single or mixed combination
  - a) Oils

2. DRAWING – includes any single or mixed combination
  - a) Pencil
  - b) Pen & Ink
  - c) Stencil

  - f) Pastels

  - h) Digital
  
3. SCULPTURE/HAND ARTS – includes any single or mixed combination
  - a) Clay Sculpture
  - b) Scratch Board
  - c) Mosaic
  - d) Pottery
  - e) Paper Mache
  - f) Wood Burning
  - g) Collage
  - h) Sand Art
  
4. OTHER
  - a) Coloring on Pre-printed Paper
  - b) Mixed Media - combination of two or more medias from class 1 or 2

## PHOTOGRAPHY DIVISION

Only entries of single photographs will be accepted (no collages). Class is determined by focal point of picture. It is extremely important that exhibitors review the descriptions of each category very carefully. Do not enter photographs into categories that are duplicates from other categories or ones that do not clearly meet the category description. Photographs that do not meet the description of the category will be disqualified. Pictures may be taken with any camera. All photography entries **MUST** be printed as 8"x10" in dimension **AND** matted with 11"x14" black, grey or white mat with stiff backing (such as thin foam board, mat board, or heavy weight cardboard), must be securely adhered together to create a single photographic display, and must have a hanger attached securely to the back (wire, string, pipe cleaners, etc. with tape, glue, etc.). Framing or matting with a glass frame of any kind is **NOT** allowed. Mats and backing are available at Hobby Lobby, Michael's, Amazon, or local photography and art stores.

### Class

1. **ANIMALS - DOMESTIC** Photos focusing on the various animals that have been tamed and made fit for a human environment. To be considered domesticated, the animal must have their behavior, life cycle, or physiology systemically altered as a result of being under human control for many generations. **Examples:** Chickens, cows, dogs, cats, hamsters, horses, pigs, sheep, goats, etc. All waterfowl (ducks and geese) should be entered in Animals - Wildlife.

2. **ANIMALS - WILDLIFE** Category focuses on animals not typically tamed or domesticated and commonly found in the wilderness or bodies of water throughout the country and world. Photos can be of wildlife in nature, zoos, and/or petting zoos. **Examples:** Birds, deer, elephants, snakes, whales, etc.

3. **CATCH-ALL** Photos that do not fit into one of the other categories. **Not allowed:** A duplicate photo also entered in another category.
4. **DETAILS & MACRO** Getting in close is the name of the game for this category. The goal is to zoom in close on an object to see its finer details or to make small objects appear life-sized or larger than we do not normally get to see with the naked eye. **Examples:** Insect eyes, veins on a leaf, a reflection in a water droplet, etc.
5. **ELEMENTS OF DESIGN** Images use of graphic elements of design. Photos that showcase line, shape, pattern, form, texture, perspective, etc. Photo can consist of any subject matter. **Examples:** Line, pattern, perspective, shape, etc. **Not allowed:** Digital creations or graphic designs made in software such as Photoshop, InDesign or Illustrator.
6. **ENHANCED** A single photo that has been technically manipulated to be an abstract, panoramic, stitched or composite image. Other variations are allowed as well. **Examples:** Software edited composites and creations, images greatly manipulated with a variety of filters, photos with artistic borders, photos stitched into a panoramic, etc.
7. **FOOD** A still life specialization of photography, aimed at producing attractive photographs of food for use in such items of advertisements, packaging, menus and/or cookbooks. **Examples:** Cakes/pies, Easter eggs, fruits and place settings, ingredients, sandwiches, Thanksgiving dinner, etc. **Not allowed:** A photo of alcohol beverages.
8. **LANDSCAPE & NATURE (NON-ANIMAL)** The focus of this category includes landscapes, outdoor scenic, nature images, sunsets, urban landscapes, seascapes, cityscapes, and farms. Images focus on the beauty of the outdoors. **Examples:** Gardens/landscapes, outdoors, scenic, etc. **Not allowed:** Primary subject is a person or wildlife.
9. **LEADING LINE** This image composition technique features lines that draw the viewer's eye from point A to point B, which is the primary subject. **Example:** A river that begins in the foreground and draws your attention to a photogenic bridge in the background

10. **LONG EXPOSURE** Also known as time-exposure or slow-shutter; this technique involves using a long-duration shutter speed. It can be used to sharply capture stationary elements of an image while blurring, smearing, or obscuring the moving elements. It is also used in low-light conditions. **Examples:** fireworks, moving water, light trails, Milky Way, light painting, night or low-light conditions, etc.

11. **MOTION/ACTION** The capture of movement within a single photo. The subject appears stopped or “frozen”. **Examples:** Ferris wheel spinning, sporting events, horse running across a field, etc.

12. **PEOPLE** Photos focus from all walks of life, parenting and family, children, babies, models/fashion, sports, and couples. All individuals in the photos must have provided consent and permission as a subject. If requested, a release will be needed from the photographer and subject. **Examples:** Babies, families, kids, portraits, models/fashion, etc.

13. **PLANT/FLORA** Photos of interesting, unique, and beautiful flowers and flora. Photography can take place outdoors or indoors. Photo subject should be that of a single flower, plant, bush, tree, etc. Large collections of plant/flora should be considered for entry into the Landscape & Nature category. **Examples:** A rose, an upward shot of a tree, etc.

14. **SHADOW/SILHOUETTE** A silhouette is an outline that appears dark (typically a single color) with little or no details/features against a brighter background. Recording patterns of light and shade for a desired effect or emphasis is the definition of a shadow. The silhouette or shadow must be the primary subject and focus of the image. **Examples:** shadows/silhouettes of people, plants, animals, structures, architectures, or natural structures. **Not allowed:** reflections

15. **THEMED** photo related to any aspect of the Victoria Livestock Show **Examples:** parade, Queen’s pageant, livestock projects, etc.

## **CRAFTS & HANDWORK DIVISION**

Class is determined by material and method. All items must be finished and ready for wear or use. All items must be clean and brought to check-in on hangers, fastened securely, or on a quilt rack or display rack. All small items, such as jewelry, small models, small personal accessories, and beading, need to be placed in a pint, quart, or gallon sized zip bag.

## SHOP & HORTICULTURE DIVISION

All items must be finished and ready to use. All potted plants must be in the exhibitor's care at least 90 days prior to check-in. All potted plants, including hanging baskets, must have saucers underneath for watering purposes. All plants should be clean with dead foliage removed and in clean, proper containers.

### Class

- 1) **POTTED ARRANGEMENTS** Any type of live plant in a pot.
  - a) Floral, Fruit, Vegetable, Succulents, Cactus, etc.
- 2) **CUT ARRANGEMENTS** Any type of fresh cut plant.
  - a) Fresh Cut in vase, Fresh Cut on Wreath, etc.
- 3) **DRIED ARRANGEMENTS** Any type of cut and dried plant no longer fresh.
  - a) Dried in vase, Dried on Wreath, etc.
- 4) **ELECTRICITY AND WIRE**
  - a) Any type of electrical work or items made of wire
- 5) **LEATHER**
  - a) Any type of leather work
- 6) **METAL**
  - a) Any type of metalworking or blacksmithing such as welding, signs, barbeque pits, fire pits, knives, etc.
- 7) **PLASTIC**
  - a) Any item made from PVC, 3D Printed, etc.
- 8) **WOOD**
  - a) Any type of woodworking such as furniture, tables, benches, signs, pens, etc.
- 9) **TAXIDERMY**
  - a) Any type of taxidermy such as mounting antlers, shoulder mounts, hides, etc.
- 10) **GLASS**
  - a) Any type of glass work, stained glass, blown, etc.
- 11) **OTHER**



## FOOD DIVISION

Any food item that requires refrigeration will NOT be accepted.

All bakery food items MUST be in a closed store bought, disposable bakery container on a plain white, gold, or silver cake circle/rectangle. These may be purchased at Hobby Lobby, Amazon, other online websites, or local food/bakery supply stores. All items cooked directly in a store bought, disposable pan with lid will be accepted as a bakery container, such as pies, tarts, cobblers, and sheet cakes. Exceptions that require other containers are candy, snack mixes, canned items, dried meats, and beverages. See chart below for additional details. Any food item not in the appropriate container WILL NOT BE ACCEPTED and DISQUALIFIED.

**Recipe must accompany and be attached all food entries.** Recipes including ingredients, amounts, and step-by-step instructions must be typed on standard 8 ½" x 11" plain letter paper in black ink with no decorations or photos. Exhibitor name must be on the back of recipe.

All canned/bottled products must be in standard jars, pint or quart, and canned/sealed with safe canning techniques. Two (2) jars/bottles need to be submitted - one for tasting and one for display. Any canned products will be disqualified if exhibited in mayonnaise jars, coffee cans, or any other jar/can that is not a standard canning jar. All canned product jars must be clean and un-chipped with new lids and rings. All canned products must be sealed with only one lid. The use of paraffin is prohibited.

Baked products (cakes, pies, breads) must be brought in whole. Brownies, cookies, candies, etc. must be brought as a sample of six (6). See chart below for more details.

**Food items will need to be remade fresh and whole for silent auction. Additional jars of canned items or bottles of beverages will need to be available for silent auction. Please keep this in mind when making your items.**

Food will be judged on appearance and taste unless otherwise stated below.

## AGRICULTURAL MECHANICS PROJECT SHOW

See Schedule for deadline, check-in, judging and release dates and times.

1. Exhibitors may enter as many projects as they desire. On group projects, the group should consist of a majority of Victoria County residents.
2. All projects must be the work of the exhibitor. A project must have been constructed between the date of the previous year's show and the date of check-in. A project can be exhibited only one time at the Victoria Livestock Show.
3. All projects must be painted and properly treated and must be clean and in a presentable condition even though they may have been used.
4. An original working plan or drawing, photographs showing stages of construction and a bill of materials are required with each project and must be properly displayed.
5. Appropriate and safe display stands are to be provided for gates, panels, and other projects that need support. Sharp edges and points are to be padded and/or covered as necessary to prevent possible injury. Heavy BBQ pit lids or doors must be secured open to prevent possible injury.
6. Every precaution will be taken to protect the projects entered; however, neither the VLS Board of Directors nor the officials of this Division will be responsible for any loss or damage to projects.
7. The standards for judging will be as follows:
  - a. Workmanship 30 points
  - b. Variety of skills performed 30 points

c.	Design and materials used	10 points
d.	Degree of difficulty	10 points
e.	Desired finish	10 points
f.	Plans, photos, bills/materials	10 points

8. There will be four classes for projects and the Chairman of the Ag Mechanics division will make the decision as to which class the project belongs.

Class I – Metal working projects (at least 60% of the skills and construction time spent building the project involved metal working skills)

Class II – Woodworking Projects (at least 60% of the skills and construction time spent building the project involved wood working skills)

Class III – Other

Class IV – Tractor Restoration

9. Only the judge and show officials will be allowed in the exhibit area during the time the exhibits are being judged. It is recommended that exhibitors be with their project during judging to answer questions and explain their project.
10. Prize money will be paid for class placing as available. The first and second places in each class will compete for grand and reserve champion of the show for additional prizes. Prize money and awards will be given to only one exhibitor - the exhibitor who pays the entry.
11. Grand and Reserve Champion Ag Mechanics winner may choose to sell their project in the live auction on Monday night and should communicate with the auction committee prior to the sale.

12. Projects exhibited must have been constructed by FFA or 4-H members, either as part of their school, 4-H or home project. All exhibitors must follow U.I.L. regulations. Victoria Livestock Show will provide a standard exhibitors name tag for the projects related to the shop division.
13. Projects can be shown in either the Agricultural Mechanics or County Fair, but not in both.
14. Entry fee is \$20.00 per project entered and is to be paid online via Showworks.
